- After much volatility markets ended on the losing side with Nifty ending at 11582 down 21 points
- An Engulfing Bearish line as formed as Nifty closed lower on account of somewhat weakened position of the ruling party in state elections. The Engulfing Bearish candle formation near the top is a clear sign that the momentum is shifting in favor of Bears following a strong rally over last six days
- > 11550 has emerged as strong support for past 3 days. On violation, the index is expected to test 11520. More downside risk would open if even that gets violated with next support coming in at 11440
- > On the higher side, it is getting extremely difficult for the markets to sustain above 11650 particularly with Bank Nifty coming under tremendous pressure.
