- Plunging growth numbers and rising trade war temperature had a cascading effects on Indian markets as stocks plunged sharply with Nifty suffering biggest fall of the year, down by 225 points to end at 10797
- > Markets are under severer pressure due to several issues gripping the sentiments, the prime factor being the economic woes. The big black candle formed suggests more downsides after a brief move towards 11000.
- For past one month, Nifty has traded around the long term trend line support extended from the lows of 7056-7964-10004. Failure to move higher despite repeated attempts indicates that the index has lost the force to fight and recover and is set for fresh lows.
- > Immediately, 10720-10650 act as near term support. On the higher side, 10850-10900 is immediate resistance range.
