- Market had a volatile session today as Nifty swung wildly before ending near the day low of 11157, losing 65 points.
- The markets are entrenched firmly into bear grip, as such every rise gets sold into. After almost hitting 11300 during the day, markets faced heavy sell off towards the fag end to wipe off yesterday's gains and ended near the lows.
- The black candle formation too suggests weakness. It looks like that the index could see a lower opening tomorrow and test the lower channel line and 61.8% retracement levels and a rising gap range, each almost at 11060 range. There is a probability that lower support levels may invite a strong bout of short covering
- > On the higher side, 11250 and 11300 remains crucial resistances. Only a cross above 11300 would signal a minor trend reversal
